














# World Wetlands Day in Glamorgan Spring Bay


In line with World Wetlands Day 2010, 'Catchments to Coasts' have worked with local partners to produce a brochure on our internationally recognised Moulting Lagoon.

## What is World Wetlands Day?

2 February each year is World Wetlands
Day. It marks the date of the adoption of the Convention on Wetlands on 2 February 1971, in the Iranian city of Ramsar on the shores of the Caspian Sea.

What is its aim? To raise public awareness of wetland values and to promote the conservation and sustainable use of wetlands worldwide.



# Glamorgan Spring Bay Natural Resource Management Committee

In 2005 the Glamorgan Spring Bay Council recognised the importance of integrating Natural Resource Management (NRM) into its core business and activities.

The decision was made to establish a "Special Committee of Council", made up of key stakeholders, land managers and community representatives to help develop strategies and policies on Natural Resource Management and to advise Council.

Nominations were sought for representatives and in early 2006 the committee commenced work under the leadership of John Cotton as Chairperson.
