





### Mayoral Message

Welcome to the Spring edition of SeaSpeak,

The last couple of months have been significant in the ongoing journey for Glamorgan Spring Bay Council.

In June Council unanimously passed its 2023/24 budget and rates resolution. This was a noteworthy achievement given a period of economic turmoil including the Hobart Consumer Price Index (CPI) running at 6.9%. This CPI was more than double the financial forecasts of 12 months ago. Council also had to accommodate substantial increases to waste management costs, outside of its control and in the order of \$750k.

Despite these substantial costs pressures Council was able to keep rates revenue at a level that was lower than was forecast in the Long-Term Financial Management Plan (LTFMP). Holding the budget to plan and achieving a better than expected outcome has been the result of continuous and

prudent assessment for value, cutting of waste and review of all available income options. The LTFMP continues to provide focus for Council to be sustainable for future generations.

The 2023/24 capital works budget is \$7.3million including \$4.9million for grant funded projects. Key priorities of the capital program are the continued renewal of unsealed and sealed roads. This is in line with the community budget survey feedback that highlighted the importance of roads to the ratepayers and road users of our municipality.

In July Council announced cohealth as the preferred tenderer to operate its medical practices in Triabunna and Bicheno. A leading not for profit community health agency cohealthhas well-respected expertise in managing medical practices. The Council decision is a significant step forward for our community particularly given the historical trials and tribulations of Council managing health care practices. The future looks bright for the provision of health care in our community and we are delighted to welcome cohealth to the area.

At the time of writing the Premier had announced that there would be no forced amalgamations as part of the current local government reform process. Notwithstanding this announcement, Glamorgan Spring Bay Council remains committed to reform where it serves the residents and ratepayers of our municipality well. Council remains open to discussion with all stakeholders as we continue the reform journey together.

# From the General Manager

ear residents and ratepayers,

Spring has sprung and I reflect on a very important and consequential period since the winter SeaSpeak edition.

Councils endorsement of a preferred tender, cohealth Ltd, for the provision of primary health care services in our municipality is a significant step forward for us and potentially ground breaking for Tasmania. The Mayor has covered more of this good news story in her message but I would like to take the opportunity to thank all stakeholders, in particular the Council staff who have enabled us to get to this position. Their efforts cannot be underestimated.

The unanimous endorsement and adoption of the 2023/24 budget estimates and rates resolution in June was also significant. For the first time in many years Council will be funding its asset renewal at 100%. The budget responds to the Asset Management Plan reviews that have taken place over the last year, asset revaluations as required by the Tasmanian Audit Office and external market forces. The 2023/24 budget includes an increase of \$0.9million from last year. This investment to the 100% measure will see significant reduction in deterioration of asset condition in the coming year.

The \$7.3million capital works component of the budget includes major projects in Bicheno and Coles Bay. In addition, there is a focus on the unsealed and sealed road network renewal, Councils biggest asset in terms of value, and the most important asset as indicated by residents in the Community Budget Survey.

In adopting the Budget Council is addressing budget deficits leading to depleted cash reserves and lack of investment into asset maintenance which as history has shown, leads to a loss of financial sustainability and recoverability.

An impressive response to the aforementioned Community Budget Survey assisted Council in its budget deliberations. (See Winter SeaSpeak or Council website for survey info)

that it will shortly be commencing development of a new legislated pathway to allow some planning decisions to be made by an independent Development Assessment Panel established by the Tasmanian Planning Commission, rather than those decisions being made by Councils as planning authorities.

The initiative is about providing a second decision making option, where the 'politics are removed from planning', and is intended to assist with meeting Tasmanias affordable housing needs by reducing unnecessary delays. The Government states that it will consult widely with Councils and the Local Government sector more broadly, to identify the types and scale of projects, and provide clarity on the circumstances where applications can be referred to the independent assessment panel.

The Government intends that draft legislation will be out for consultation towards the end of this year for introduction to Parliament in early 2024.

### **Orford Foreshore Master Plan**

Parks and Wildlife have finally endorsed the Orford Foreshore Master Plan. This is great news for our community and for the environment.

The foreshore has significant conservation values with the mouth of the Prosser River being a very important foraging and nesting area for seabirds and shorebirds. The foreshore is also an important recreational area and Glamorgan Spring Bay Council has recognised the need to balance recreation and conservation in developing the Master Plan.

The Plan will assist land managers and the community to:

- better understand, conserve and mange natural and cultural values;
- improve community and visitor experience;
- improve the provision of appropriate recreational facilities and;
- enhance community connectivity between the Orford foreshore and the town centre

# Works and Infrastructure Update

#### **Road works**

In response to both community identified priorities and asset management plan identified risks and priorities, additional funds have been made available in this year's budget to fully fund asset renewal. That means after many years of asset decline, the level of funding is now sufficient to hold asset condition as is, with no further decline in the overall level of asset condition and service.

The reseal and pavement renewal program has sufficient funds to make a substantial difference to the worst roads in the municipality. This year that will include Sally Peak Road which has reached the top of the list for worst condition. Renewal will include resetting of culverts, box out of the worst pavement deviations and pavement rehabilitation and resealing.

Other selected roads in Bicheno, Coles Bay and Orford are in the program this year. These works generally commence in January and run through to the end of April.

#### Footpath and Kerb renewal

With the changes made in this year's budget, funds have been made available to dedicate to footpath renewal, which frequently requires kerb replacement as well to make kerb ramps disability compliant. No funding had been provided for these key asset classes in recent years. Staff are putting together



a program to renew existing footpaths at present with \$300,000 in footpath and kerbs to be renewed this financial year. Priority will be given to defective footpaths in high pedestrian traffic areas and includes pedestrian ramps.

#### Stormwater infrastructure renewal


Funds have been allocated to continue with Council pipe and pit program and for renewal works. This allocation enables officers to complete projects which have been unfinished for many years and generally improve the existing pipe and pit network.

Recent works include Sand River Road where a corner has



been widened in response to a collapse of the outside corner of the road above a steep bank. Co-funding from the Defence Force has enabled this work to be conducted.

Works continue on Wielangta Road to stabilise the inside corner which collapsed in late 2021



during storm conditions. The contractor was required to establish a solid base, remove all loose soil and rock and backfill with suitable quarry materials. This work is cofunded from the State Governments Natural Disaster Relief to Local Government Policy.

Swansea main street works are progressing well with final elements underway and practical completion likely in August.

Customer requests are a valuable source of information for Council's service provision. Requests filled in online and those taken by phone provide statistics for us to track on where the most common issues in service provision of failure are occurring. We encourage residents to log their infrastructure concerns through this system.

#### Change to mowing of nature strips



The Glamorgan Spring Bay Council will stop regular mowing of nature strips adjacent to private properties, commercial properties or properties owned by government authorities, except in key strategic locations and areas, or where the service is provided under any assistance program, from the end of July 2023. The considerable savings from this program will be directed back into road and footpath renewal programs within the community. These areas were highlighted in the recent survey undertaken by ratepayers as a priority.

Many residents were already mowing nature strips in between Council mowing programs. All residents may now undertake the maintenance of their nature strips, other than trees. There is a level of risk with mowing nature strips as a property owner's home insurance may not cover the public liability risks in the event of an incident and Council's insurance may also not cover the incident. Thrown stones are the most likely incident to occur. Residents may like to consult their insurer about their cover.

Council will continue to mow nature strips when they become a hazard and for fire abatement if left untended.

Where a resident is unable to maintain their nature strip due to age, disability, or illness, or need help maintaining their nature strip, they may be eligible for assistance.

People who need assistance may be covered through My Aged Care, National Disability Insurance Scheme, and other aged care providers under help at home services.

Collection of nature strip clippings is not recommended as Council practice has been to leave the clippings in place. This accords with current recommended horticultural practice for a healthy lawn.

#### Bin springs available

What bins springs do:

- Reduce spills from your bin and helps stop loose rubbish
- Protects bin from wind, smells, birds and animals
- Protects your bins from damage if knocked over
- Resistance to UV rays and extreme temperatures

Bin Springs are available from the Triabunna Council Office for \$15 each.



Glamorgan Spring Bay Council Compliance Officers will be undertaking a Municipal Dog Registration Audit between the months of September and November to encourage responsible pet ownership and help build a safer, happier community. Any dogs found to be unregistered will result in an infringement of one (1) penalty unit per offence (\$195.00) being issued, in accordance with *s.8(1)* of the *Dog Control Act 2000*.

Under the *Dog Control Act 2000*, all dogs aged six (6) months and over are required to be registered and microchipped by 30 June each year (this includes working dogs).

Be a responsible pet owner by registering your dog with Council and ensure that the tag provided is always worn. Registering your dog increases the likelihood of your pet returning should it become lost. A pension concession is available for one (1) dog, once the concession card has been sited and validated by a Council Officer. If in the unfortunate situation that your dog is deceased or is no longer at your premises, you are obligated to notify the Council. Once notified, Officers will cancel the registration and you will not receive any further registration reminders.

#### **Kennel Licensing**

Council's Compliance Officers are currently undertaking a Kennel Licence audit.

If you have more than two (2) domestic dogs, or more than four (4) working dogs aged six months and over residing at your premises, you are required to hold a Kennel Licence in accordance with s.50 of the *Dog Control Act 2000*.

### Vietnam Veterans' Day – Remembering their Service

On the 18 August 2023, the anniversary of the battle of Long Tan, we remember one of the largest battles fought by Australians in the Vietnam War. On that day, outnumbered by at least 10 to one, Australian Soldiers withstood a massed Viet Cong (an abbreviation of Vietnamese Communist) attack and suffered the heaviest Australian casualties in any single engagement in Vietnam.

Only three months earlier, the soldiers of the 6th Battalion, Royal Australian Regiment (6RAR) and arrived in South Vietnam and the Australian operational base of Nui Dat.

In the days before the battle, patrols had found no sign of enemy activity despite radio signals indicating the presence of strong Viet Cong forces within five kilometres of the base. On the day before 17 August 1966, the base had come under fire.

In response to that attack, the 6th Battalion, the Royal Australian Regiment (6RAR) was directed to find the Viet Cong's firing positions. At midday on 18 August D Company followed parallel cart tracks leading away from the firing positions into a rubber plantation towards the abandoned village of Long Tan.

It may have been just a routine patrol, with some disappointed they were going to miss a much-anticipated concert by Australian celebrities Little Pattie and Col Joye. The performers had arrived by helicopter as D company left the Task Force area, and the men could hear the band setting up as they moved away from the base.

When they entered the Long Tan rubber plantation, they had no idea that less than an hour later they would be fighting for their lives. The infantry company of 108 men would be all but cut off and almost surrounded.

As D Company moved through the rubber plantation (with two platoons up and one platoon moving behind), 11 Platoon on the right ran into a small group of Viet Cong. After a short exchange, the enemy fled eastwards with 11 Platoon in pursuit.

Just after 4.00 pm, 11 Platoon was forced to ground after coming under heavy fire. The 10 Platoon was ordered to move to 11 Platoon's help; however, the 10 Platoon was also stopped by intense fire.

With the two Platoons cut off and as rain and mist blanketed the plantation, the 108 men from 'D' Company fought for their lives against a force estimated to be up to 2,500 men.

Australia's casualties were 18 killed and 24 wounded. Although that number exceeded any other single day loss in the Vietnam War, the number could have been much higher given the disparity in troop numbers between the two sides.

The battle of Long Tan has never been forgotten. On the third anniversary of the battle, 6RAR – renamed 6RAR/NZ (ANZAC), with the addition of two New Zealand rifle companies, returned to the battle site to commemorate the losses in the Long Tan action and erect a cross in memory of those who died.

On Vietnam Veterans' Day 18 August 2023 there will be a nationally broadcast commemorative service to mark the 50th anniversary of the end of Australia's involvement in the Vietnam War. More locally, the Swansea RSL, East Coast Heritage Museum and War Memorial invites Veterans to help place a Long Tan cross within the War Memorial gardens in Swansea.
